

### December Meeting

**SPEAKER** 

"A lively comely young nymph . . . dressed in man's apparal has been discovered."

With that intriguing quotation from a story in the January 10, 1784 edition of the *New York Gazette*, our December speaker began his presentation entitled "Women Soldiers in the American Revolution." The speaker was me, and what follows is a brief, and hopefully unbiased glimpse at that talk.

Appearing not long after the signing of the peace treaty with Britain, and only a few weeks after the Continental Army had been disbanded at West Point, the quoted story concerned one particular "woman soldier," Deborah Sampson, the centerpiece of the presentation. Sampson had disguised herself as a man, enlisted in the Continental Army, and served with distinction for almost a year and a half. On July 3, 1782 she was wounded in battle, shot twice by musket balls in her leg, and receiving a sword gash to her head. Sampson was certainly not the only woman to bear arms or enlist in disguise in the Revolution, but she was the best documented. After the War she became one of the first female public lecturers. She would begin her lecture dressed as a woman, changing later into her uniform and performing the manual of arms with expert precision.

#### **NEW MEMBERS**

Only one new member was inducted at the December meeting, Mr. Gary E. Wood of Lakeway. After Henry Shoenfelt administered the oath, Mr. Wood shared what information he said he had about his patriot ancestor, Bernard Franklin, namely, that Franklin had provided supplies for the revolutionary cause in North Carolina.

Further research reveals that Bernard Franklin was born in 1731 in Virginia, and moved to North Carolina around 1778, settling in a valley near the head waters of Mitchell's River, in Surry County. One published history says that this homestead of the family "became well known as a center of patriotism and honor, culture and refinement."

Bernard's son Jesse served first as a lieutenant in Washington's army, and then later achieved the rank of Major. During Jesse's service he was captured by Tories, but escaped, and fought at the battles of King's Mountain and Guilford Courthouse. He later became a U. S. Senator from, and then governor of, North Carolina.

#### **BUSINESS**
